THE 'PROBLEM OF THE GAS CHAMBERS'

BY ROBERT FAURISSON¹

(Professor Robert Faurisson wrote the article below in 1978. It was widely circulated in France and was translated and published in the Summer, 1980 issue of *The Journal of Historical Review*. No one has been able to refute any of the facts presented.)

No one, not even among those individuals who regard the Third Reich with nostalgia, denies the existence of concentration camps under Hitler. Everyone recognizes also that certain camps were equipped with crematory ovens. Instead of being buried, the corpses were reduced to ashes. The repeated occurrence of epidemics made cremation necessary, especially for those who had died of typhus (see the photos of mass graves at Belsen *et cetera*). What is, however, disputed by numerous French, British, American and German authors is the existence of "extermination camps" in Hitler's Germany. This expression is used by history writers to refer to those camps which are supposed to have been equipped with "gas chambers." These "gas chambers" were different from the American gas

hen orthodox history deals with the "Holocaust," it knows no bounds, it recognizes no limits. How could it, when the "Holocaust" story, based largely on the testimony of witnesses who demand complete immunity from cross examination, ceaselessly exhibits all the protean shifts and changes of an amoeba?

First the Germans were supposed to have steamed the Jews like lobsters at Treblinka, and electrocuted them en masse at Sobibor. We don't hear *those* stories any longer, but where is the Establishment historian who will tell us why? Men were prosecuted and put to death for gassing Jews at Dachau, Sachsenhausen and other camps in Germany proper, but then we learned in 1975 from Mr. Nazi Hunter himself, Simon Wiesenthal, that there were no gas "extermination factories" anywhere within the borders of the *Altreich* [Old Reich]. First Buchenwald and Dachau, then Auschwitz, now Treblinka, Belzec and Sobibor are trumpeted as the big extermination centers.

But that's just the tip of the iceberg. The anomalies, the inconsistencies, the physical impossibilities, and the outright, brazen absurdities of the Holocaust story have remained unchallenged by every one of the Establishment's professors, while the professional "survivors" continue to blare their falsehoods to media adulation in the biggest PR campaign the world has ever seen.

But things are beginning to change—*around the world*. Not only in America, but in Europe, in Latin America, even in Japan, concerned men and women are beginning to stand up and debunk the "Holocaust." In Canada where it is illegal to bring Revisionist books into the country, Ernst Zündel battles for his right to free speech in his adopted homeland—and against efforts to send him into exile. In France, Henri Roques fights to regain the doctorate the state revoked after he dared examine the bizarre "confessions" of Kurt Gerstein. Schoolteacher Mariette Paschoud is muzzled in Switzerland for supporting Roques, while in Germany the state-imposed censorship bans Revisionist classics outright and strips Wilhelm Stäglich of his duly earned doctorate under a law proclaimed by Adolf Hitler!

inspected in Auschwitz, Birkenu or Majdanek was capable or would have been capable of killing massive numbers of humans in WW II or now!

That was a bombshell! The gas chamber myth had been exposed scientifically as an Allied propaganda fraud!

Panic Strikes Zionists

There was upset, panic and consternation in Jewish ranks in the spectator gallery! Leaders from the various Zionist organizations began arriving in droves. The cross-examination was short and messy! I had been negotiating with the world-famous British historian David Irving to be a potential witness!

I read him some of the details and then he said that he had suspected for some time that something might be terribly wrong with the standard version of the "Holocaust".

The Zundel Trial

World War II was plot by Zionists, witness says

World War II was a Zionist plot to make way for the foundation of the new state of Israel, a witness in defence of Ernst Zundel testified yesterday.

Joseph Burg, 80, who described himself as "anti-Zionist," said Zionists and Nazi leaders collaborated on Jewish migration from Europe to Palestine.

Leaders of "world Zionism" were "willing to sacrifice the whole of European Jewry for a Zionist country," Burg said.

"Everything had to be done to create a state of Israel and that was only possible by world war," Burg said. "Wall Street" and "Jewish large bankers" were the war effort.

Zionists are also to blame for provoking growing hatred of Jews today, he said.

Burg, a Romanian of Jewish parentage who now lives in West Germany, said he spent the war in a concentration camp, although he said he had a pass to move freely.

He said there were "individual foreign ethnic groups" who attacked Jews, but there was no organized Nazi government attempt to exterminate Jews.

Zundel, 48, is charged with knowingly spreading false news in a pamphlet entitled Did Six Million Really Die? written by a member of Britain's National Front, a right-wing, white supremacist organization.

Burg said he was testifying on behalf of Zundel because Germans have been incorrectly blamed for murder.

"If there were another two or three Zundels it would be better for Jews as well," Burg told the jury.

Fred Leuchter

Fred Leuchter, an American engineer from Boston was the next witness. He was witness #22, and had been commissioned by me to go behind the Iron Curtain, to visit and inspect the so-called extermination camps of Auschwitz I, Birkenau and Majdanek, to inspect all the camp facilities, but with a special eye on the alleged gas chamber installations in the camps.

Leuchter went as part of a 5 person team of engineer, draftsman, translator, video photographer and lookout.

They were to film, photograph, measure and virtually survey these gas chamber and crematorium installations there. They were to record all, to prepare exact engineering type drawings. They were furthermore to take rock and concrete samples from the walls, floors, ceiling and drains of these alleged Nazi killing centres, to have these samples flown to the U.S.A. to be analyzed by a neutral U.S. lab, which was not to be informed of where these samples came from and for what purposes the analyses was to be made!

Dr. Faurisson had found this expert through letters sent by one of my attorneys to various U.S. prisons and penitentiaries. Warden Armontrout had given us Fred Leuchter's name.

When Dr. Faurisson first visited Mr. Leuchter in Boston, we found out to our horror that he believed in the Hollywood version of the Holocaust. Dr. Faurisson called me back and asked: "What should we do?" Could we risk to work with such a man. Dr. Faurisson decided to leave some photos, maps and scientific as well as revisionist papers with Mr. Leuchter overnight.

The next day another meeting was to take place between the two men. Dr. Faurisson was not quite sure how we should proceed, and I suggested he should invite Mr. Leuchter to Toronto. Leuchter accepted and flew to meet us at our Toronto offices.

We spent a long and tiresome weekend looking at film footage and slides from Auschwitz taken by Dittlieb Felderer and Jürgen Neumann.

We looked at crematorium plans, camp maps, at books sold by the Auschwitz Museum. We looked at the scale models I had prepared which corresponded to German plans from 1943.

The engineer in him was by now very interested in an engineering problem. He said he would go, but the costs he mentioned, what with 5 flights to Poland, hotel rooms, car rentals, professional fees for himself and his draftsman, made the project financially just about impossible for me to undertake in the middle of an already very expensive trial.

Money, Money, Money

I called around to my friends for help. I begged, cajoled, stroked egos; in the end, there still was not enough money to undertake the mission. Mr. Leuchter had to go back to Boston. I just did not have the money to send him on this once in a lifetime mission.

7 I promised to call him back as soon as I could afford the trips. I spent every waking hour of the next few days, trying everything I could think of, even putting cameras to pawnbrokers, or borrowing money from banks.

These ideas soon showed themselves to be unreliable, because with my name in the papers everyday and with headlines like "Anne Frank Diary a Hoax", "Zionists Started WW II", etc., there was no one to give me any credit.

Mission to the Scene of the Crime

In the end I decided to send Fred Leuchter and his team anyway! I was going to pay him in installments. His first bill came to almost \$17,000 and his second bill amounted to \$21,000; this together with flights, hotel and car rental bills, food, etc. I was staggering under the impact of these bills!

The mission to Poland went off without a hitch. The films were taken and so were the samples. The tests done on the samples in America produced just about the most astounding results. The delousing facility samples showed a high HCN (Zyklon B) content of 1050 mg. per Kg; the samples from all the alleged gas chambers showed either no trace of cyanide or extremely low levels below 10 mg., certainly not due to mass and frequent execution gassings! (See Graph)

In the end, Fred Leuchter prepared a hefty 192 page scientific report for me on his findings in Majdanek, Auschwitz and Birkenau. His conclusions were to be presented as expert witness testimony. We were going to use his photos and maps as well as his graphs and project them on a screen for the jury to see and evaluate.

On April the 20th, 1988, Fred Leuchter had a date with destiny. All night a team of chemists, typists, computer operators, and photocopy experts had worked like beavers to get the report done. By 9:00 a.m., 5 bound versions were ready. By 9:30 we left in our minibus to the courthouse. By 10:00 a.m., Doug Christie asked the judge to be heard in the absence of the jury. He introduced Fred Leuchter.

Panic befell the Crown and the Judge! The arguments wafted back and forth and we almost were shut out. Only after we mentioned that we had videotaped the entire procedure in Poland did the Judge suddenly change his tune. Leuchter was in!

His evidence was restricted, but at least some of it would go in, and the "Holocaust" was about to go up in "smoke".

We Make History!

For the next few hours, history was going to be made in courtroom 4-6 in the District Court in Toronto, as this American engineer, the only man still alive dealing with homicidal gas chambers and the only expert in the world, was to tell the court that in his best engineering opinion, not a single installation he had
