the Allied Military Joint Commander to the Commander German Land Forces in Norway.

Part I. General.

- 1. Unless otherwise stated, the following orders will apply throughout German occupied Norway.
- 2. Members of the following auxiliary organisations and specified persons in Norway are immediately to be placed under the command of the Commander of the German Land Forces in Norway, who is to be responsible for their disarmament and discipline, as well as their maintenance and supply where applicable, to the same extent and degree as for units of the German army:
 - a) Schutz Staffel (SS)
 - b) Sturmabteilung (SA)
 - c) Nationalsozialistisches Kraftfahr Korps (NSKK)
 - d) Hitler Jugend (HJ)
 - e) Reichsarbeitsdienst (RAD)
 - f) Organisation Todt (OT)
 - g) Ordnunspolizei
 - h) Sicherheitspolizei, Sicherheitsdienst, Militärisches Amt, SS Jagdverbände and Geheimefeldpolizei
 - j) Volkssturm
 - k) Every non-German formation or unit serving with or under the control or command of any part of the German Armed Forces, including:
 - I) Beredskapspoliti
 - II) Statspoliti
 - III) Grensepoliti
 - IV) Frivillige Politikompanier
 - V) Førergarden
 - VI) Legion Norwegen
 - VII) SS Vaktbataljoner
 - VIII) SS Panzergrenadierregiment Norwegen

- IX) SS Skijegerbataillon Norwegen
- X) Germanske SS Norge
- XI) Full-time members of (NS)
 Hirden
- 1) Every person not belonging to an organisation referred to above who is serving with or attached for duty to a formation or unit under German army command or authority.
- m) Such other persons, units or organisations as the Joint Commanders may at any time specify for this purpose.
- 3. For the purpose of this order the German Army, the German Air Force Field Divisions, German Airborne Units and the above named auxiliary forces and specified persons shall be referred to as «The German Land Forces».
- 4. The Commander German Land Forces will be held responsible for the control and behaviour of all civilian Germans and German-allied nationals in Norway. These and the German Land Forces will be referred to as «Germans».
- 5. The Commander German Land Forces in Norway is to ensure that the following orders are communicated to formations and units of the German Land Forces in Norway, and that these and subsequent orders issued by the Military Joint Commander, or on his behalf by any Allied (including Norwegian) Commander, relating to the Land Forces are fully and promptly obeyed and executed. In case of any question as to the meaning of these orders the decision of the Military Joint Commander shall be final.

Arrest of Certain Persons.

- 31. The Commander of the German Land Forces is to take into protective custody immediately the following:
 - a) All personnel of: I) Sicherheitsdienst. II) Militärische ämter and Amt VII of Reichssicherheitshauptamt. III) Geheime Feld Polizei. IV) Kommando der Kleinkampfverbände. V) Sicherheitspolizei. VI) Waffen SS. VII) Allegemeine SS. VIII) Totenkopfverbände. IX) Female SS.
 - b) All officers of: I) Ordnungspolizei.
 II) Sturmabteilung. III) Hitler-Jugend.
 - c) All officials of the NSDAP holding the post of Amtsleiter or higher, or the rank of Gemeinschaftsleiter or higher.
 - d) Chief and chiefs of departments of the Reichskommissariat, and the chiefs and deputy chiefs of each of the Provincial offices of the Reichskommissariat, if these persons do not individually fall in the above categories.
- 32. Lists of persons detained under the above para 31 and also under para 34, will be prepared showing the following particulars:
 - a) Surname
 - b) Christian names
 - c) Date & place of birth
 - d) Unit
 - e) Rank, appointment and office of duty.

Minefields and Other Dangerous Obstacles.

33. The Commander of the German Land Forces is to ensure that no action is taken to interfere with any markings of minefields.

Concentration Camps.

34. The Commander of the German Land Forces is to take over immediately the administration and control of all concentration and labour camps. All existing guards and administration officers, except junior personnel required for day to day

- administration of the camps, are to be arrested and placed in confinement pending further orders.
- 35. Norwegian political prisoners held in concentration camps or other forms of custody under German control in Norway are to be released immediately, and if unable to return to their homes are to be maintained and protected by the Germans. German or German-allied prisoners are to be retained in the camps.
- 36. The conditions within the camps are to be alleviated immediately and no punishments or restrictions are to be inflicted. Food and medical attention are to be provided on the same scale as is normally provided to the German Land Forces.

Prisoners of War.

37. Pending instructions for their release or removal, all prisoners of war are to remain in their existing camps, prisons, hospitals or other places of confinement. When these are entirely or mainly utilised for the confinement of prisoners of war, all guards are to be withdrawn and camps, together with all stores and records, are to be handed ever forthwith to the command of the senior officer or other senior representative of the prisoners pending the arrival of such other person or persons as the Military Joint Commander may designate for this purpose. There is to be no removal, by the German authorities of prisoners of war, no removal, diminuation, dissipation or destruction of their property or effects, or of the stores or records, in their camps, prisons, hospitals or other places of confinement, nor any transfers between camps, except as directed by the Military Joint Commander.

Communications for Aliied Prisoner of War Camps.

38. The Commander of the German Land Forces is to maitain all existing means of communication between Allied prisoner of war camps and German Headquarters.
