1) HUGH TREVOR-ROPER ON GAS CHAMBERS, GERSTEIN AND REVISIONISM

This 30 minute interview has never been made public, and by exclusive arrangement with The Tinbergen Archives, it will not be made available anywhere else. Hugh Trevor-Roper (Lord Dacre of Glanton) is the undisputed dean of British historians. His books on World War Two and the Third Reich are still considered the standards in the genre. In 1990 Lord Trevor-Roper wrote a letter to French Holocaust revisionist Henri Roques (Roques is the man whose doctorate was revoked by the French government because of political pressure; his doctoral thesis challenged the authenticity of the "confessions" of SS hygiene officer Kurt Gerstein), and in his letter Trevor-Roper agreed with Roques that the Gerstein statement (which is among the most frequently cited pieces of evidence used to support the concept of gas chambers in Nazi Camps) "cannot be relied upon," and that "we should (at least provisionally) exclude it altogether from the evidence." As startling as these comments were, the historical community seemed all too eager to ignore them. Except for one man, a fellow academic, who asked Lord Trevor-Roper to expand on these thoughts during a taped interview.

In this 1995 interview Lord Trevor-Roper goes into greater detail about his doubts regarding the Gerstein statement, and reveals some surprising opinions along the way: Lord Trevor-Roper reveals his skepticism of *other* oft-used pieces of gas chamber "evidence," his lack of patience for the "mistakes and exaggerations" made by Holocaust scholars, his disdain for the "extremism and dogmatism" on both sides of the debate, and vehemently sounds off against attempts to censor Holocaust revisionists. Lord Trevor-Roper's comments are thoughtful and objective throughout.

2) THE BULLITT REPORT

The Report that could have prevented World War Two and changed the course of history. I can think of no other document that will make you question "official" history like this one will.

In 1936 there was a man, an elder statesman of American diplomacy, William "Bill" Bullitt, who saw the future while all around him were blinded by greed, ambition or hatred. However, returning as Ambassador to the USSR in the thirties, Bullitt found that, under Stalin, the Communist dream had become a nightmare the likes of which the world had never seen. In his 1936 report to Roosevelt, *written in Moscow*, Bullitt implores the president to act with care when dealing with Stalin. In great detail, he informs the president of the evils of Stalin's empire, and warns Roosevelt against making any hasty deals with Stalin. You won't find a more complete contemporaneous account of what was *really* going on inside the Soviet empire. Of course, FDR ignored all of Bullitt's advice and let him go as ambassador, thus sealing the fate of much of Europe and the rest of the world, dooming it to a half-century of Communist oppression. Bullitt returned home only to be crucified as a "fascist" by the "unbiased" U.S. press. When you hold this report in your hands, you'll be holding the same report that FDR decided to suppress; you'll see what FDR knew but chose to IGNORE; and you'll see what the press derided as "anti-Soviet propaganda," but what time has shown to be the truth.

Perhaps most startling of all are Bullitt's paragraphs on the preponderance of JEWS in the Soviet Bureaucracy. "The upper Bureaucracy in nearly all Commissariats is Jewish," and he goes into more detail from there.

**3) FROM CLASSIFIED STATE DEPARTMENT FILES:
THE BOLSHEVIK COVER-UP**

These days we are told by the media and our "official" historians that Holocaust revisionists are "nutty" for suggesting that government entities might suppress important information in the name of protecting Jewish interests. Revisionists are told that they are nothing but "conspiracy theorists" for proposing that governments routinely withhold information in the name of preventing "anti-Semitism." Yet here it is, straight from the State Department. The people's right to know was secondary to the government's concern about protecting its own interests, as well as the interests of these prominent families. And certainly the public - *including Jewish citizens* - had a right to know this information.

5) SS DACHAU

Few people have ever seen this extensive 70 page U.S. army report on the Dachau camp, prepared in 1945 by Colonel William W. Quinn of the 7th Army. This is the first (and, to this day, most complete) report on the Dachau camp. Every detail and facet of the camp is dissected as if with a surgeon's scalpel. Nothing is left unsaid. These are the facts of Dachau. So why, you're wondering, is this most fascinating and extensive report so little known? Well, for starters, the American liberators are told by one prominent survivor that "the SS rarely murdered anyone." The survivor who made this statement, a former university professor, is praised in the

report for "still serving the academic ideals of objectivity and truth."

Great mention is made of the fact that it was *conditions resulting from the overcrowding in the last months of the war* which led to the high mortality rate in the camp. No mention is ever made of "gas chambers."

This might not be the "Hollywood" version of Dachau, but it is the undeniable truth, as the 7th Army saw and recorded it.

But there is something in this book of even greater importance, perhaps one of the most startling pieces of hidden history I've ever come across. Hidden in the midst of this book about Dachau is a densely typed 15 page report that could affect the Holocaust debate as much as any document, ever: The deposition of E. Hodis, inmate mistress to Auschwitz Commandant Hoess! But not a deposition taken by the Allies; this deposition was taken in 1944 by the SS investigating commission under Judge Konrad Morgen, who was specially empowered by Himmler to root out corruption and violence among the concentration camp commandants! One of Morgen's men was captured at Dachau, and the Hodis deposition, which was among his effects, was unceremoniously included in the report "SS Dachau." Yet for over fifty years few have ever discovered this historical treasure, buried as it is in a book about Dachau. The Hodis deposition, taken during Konrad Morgen's investigation of Hoess, proves conclusively that the SS were intent on investigating and stopping any acts of murder among camp personnel. Hodis makes it clear that Hoess abused inmates *on his own initiative*, in defiance of orders from above, not because of them. And the deposition makes it clear that the SS, rather than turning a blind eye to these abuses, wanted instead to know every detail in order to prosecute Hoess.

Altogether, "SS Dachau" is the kind of document no serious Holocaust historian should be without. There are few documents of equal import and, because of its content, there are few documents as little known as "SS Dachau."

6) "WHY THEY CONFESS"

Must be *seen to be believed!* From a different era, when certain things could be said that are now *verboten*. A nine-page *Life Magazine* article from June 1949 written by world-renowned anti-Nazi author Konrad Heiden (*Der Fuehrer*) about how the Soviets manufacture (using torture) Nazi "confessions" for use at Nuremberg and elsewhere. Amazing. Today, saying something like that is considered heresy. Yet in 1949 it was the subject of a devastating article in *Life*.

Heiden uses as his focal point the "confessions" of Nazi propagandist (and Nuremberg defendant) Hans Fritzsche. Fritzsche "confessed" knowledge of "exterminations," and as a result, despite his lowly rank, his "confessions" have achieved a prominent place in Holocaust literature (this from *Tyranny on Trial*, a seminal book on the Nuremberg trial: "The [Nuremberg] defendants, almost without exception, denied personal knowledge of the annihilation of the Jews.... Yet the smallest of importance of all the defendants, the radio commentator who assisted Goebbels in anti-Jewish propaganda, Hans Fritzsche, a man who had no responsibilities for the carrying out of the program, confessed knowledge of the extermination measures put into operation after the attack upon the Soviet Union." Page 314).

Yet Heiden describes how the Soviets tortured this "confession" out of Fritzsche, complete with step-by-step illustrations of Soviet torture techniques! Heiden and *Life* are certainly not Nazi "apologists." It is very hard to argue with the bare facts presented here. The only question is, why can't these things be said today?

7) 1995 CRAKOW FORENSIC INSTITUTE/AUSCHWITZ STATE MUSEUM FORENSIC REPORT ON THE AUSCHWITZ "GAS CHAMBERS"

You haven't seen this one anywhere else - certainly not in any Holocaust periodicals, but also, surprisingly, not in any "revisionist" journals, either. This is perhaps the most important yet under-reported piece of revisionist news of the last few years.

As we all know, one of the most insurmountable problems faced by believers in the Auschwitz "gas chambers" is the lack of Zyklon B (hydrocyanic acid) residue and "Prussian Blue" staining in the walls of the homicidal "gas chambers," as opposed to the heavy traces and stains in the walls of the delousing chambers. You are probably also aware of the forensic tests conducted in 1988 by Bostonian Fred Leuchter, tests which demonstrated the lack of these traces. In 1990, the Crakow Forensic Institute, in association with the Auschwitz State Museum, conducted their own forensic tests in order to refute Leuchter and the revisionists, but these tests only confirmed Leuchter's findings (the 1990 test results were published in the Summer 1991 *Journal of Historical Review*).

Because of the embarrassing results of that test, as well as subsequent revisionist examinations of Auschwitz (most notably that of German chemist Germar Rudolf), the Crakow Forensic Institute and the Auschwitz State Museum decided to try again last year, this time using the most advanced, state-of-the-art forensic equipment available. With the promise of refuting the revisionists once and for all, they conducted the most extensive forensic test of the Auschwitz "gas chambers" EVER.

And what do you think were the results? Here's a hint: most Holocaust scholars were quite content to bury this report! Anyone concerned with the debate over gas chambers at Auschwitz *must* see this forensic report. It is unlikely that there will be a more thorough (and damaging) report on the gas chambers anytime soon. And if there is, will the results be trustworthy? There is cause for concern because in this 1995 report the Crakow Forensic Institute makes a major slip; they admit that they can now artificially induce hydrocyanic acid residue in brick and mortar. This is imperative for all revisionists to know, just in case any future forensic tests "suddenly" reveal high traces of residue in the "gas chambers."

8) JEWISH FRONTIER ASSOCIATION REPORT: "MASSACRE OF A PEOPLE"

lithal injection before boarding the trains east so that they arrived already dead at the Nazi "human soap factory" (this from a reliable German source"). And that's not all: "Corpses are converted into chemicals in underground factories." We are told that Jews were converted into human soap, human glue, and human train oil. Over the course of the 100 pages of this report, no outlandish claim is left unsaid. Even Jan Karski's "lime-covered sealed train cars" are given the stamp of authority.

Yet some aspects of the extermination story had not yet been officially "worked out," so we have the embarrassing blunder that in this report it is claimed that the Dutch Jews were only being used for LABOR at Auschwitz. These days we are told that the Dutch Jews were exterminated immediately upon arrival at this extermination camp." Of course, in 1943 Auschwitz was not yet the "symbol" it is today.

2) TRANSCRIPTS FROM THE KASTNER/ "HUNGARIAN JEWS" TRIAL

As most Holocaust researchers understand, the Auschwitz "extermination" story comes down almost entirely to the fate of the Hungarian Jews. With the "court Historians" now putting the Auschwitz death toll from all causes at somewhere under a million (for Holocaust author Jean-Claude Pressac, the figure is under 700,000), once one eliminates the non-Jewish victims and the Jews who perished during the many typhus outbreaks (and the Jews who died from other diseases or "natural" causes), the 400,000 Hungarian Jews who were supposedly gassed Auschwitz in 1944 make up the bulk of those "exterminated." In fact, according to mainstream Holocaust author Robert Jan Van Pelt (*Auschwitz: 1270 to the Present*), the Hungarian Jews were the *raison d'être* of the Auschwitz "gas Chambers": Himmler personally ordered the remodeling of the four Birkenau Kremas in order to exterminate the Hungarian Jews.

The Auschwitz "gas chamber" story is totally dependent on the Hungarian Jews. Without them, there would have been no reason for building four large homicidal gas chambers. Yet while every aspect of Auschwitz has been discussed many times over, how much attention has been paid to the supposed *victims* of the "exterminations?" What do we really know about the fate of the Hungarian Jews? There might not BE a more pertinent question; because, without the Hungarian Jews, Auschwitz *could not* have been an "extermination" center.

When we think of "evidence" for the extermination of the Hungarian Jews, the first thing that usually comes to mind is the Eichmann trial, which concentrated extensively on the Hungarian Jews. Yet we know from reading Hannah Arendt's "Eichmann in Jerusalem" that the Eichmann trial was planned by Israeli Prime Minister David Ben-Gurion as a "show trial" (page 4), a "lesson" to the "gentiles" (pages 9-13), and that Eichmann's defense lawyer was weak (page 9) and unable to mount a capable defense or submit exculpatory evidence because of Israeli laws (pages 221-222).

But did you know that there was *another*, earlier "Hungarian Jews" trial in Israel, one in which both prosecution *and* defense were able to argue freely and vigorously, and one in which information emerged of such an astonishing nature that few mainstream historians will *dare* speak of it? If you have never heard of the Kastner trial, prepare to be shocked.

The story: In 1953 a minor Israeli pamphleteer charged that a prominent Israeli official, Dr. Rudolf Kastner, had been a "Nazi collaborator" during the war. It was charged that Dr. Kastner, in his position as head of the Jewish Agency's Rescue Committee in Hungary, had arranged for and even *encouraged* Hungarian Jews to

go to Auschwitz. In response to this charge, the Israeli government sued the pamphleteer for "libeling a government official."

Thus began the trial that, in the words of one Israeli journalist, "laid bare the soul of Israel." The trial made headlines for months, snaring Israel's Prime Minister, Supreme Court Justices, and founding fathers along the way. So damaging was this trial that few people speak of it today.

What made the trial so damaging? And what relevance does the trial have for anyone trying to understand Auschwitz? One glance at Kastner's testimony on the stand makes it clear: Kastner says he encouraged the Jews to go to Auschwitz because *they faced no harm there!* He says the Jews were only being used for labor. To make his case he presents witnesses and evidence including letters from Hungarian Jews deported to Auschwitz for labor - letters written during the war to assure the other Jews that no harm awaited them. Kastner and his witnesses say that these letters are real, not "Nazi forgeries!"

One of the most oft-repeated questions regarding the Hungarian Jews is "if the Nazis only wanted them for LABOR, why did they deport the elderly and children?" In the Kastner trial we have the amazing answer: It was *Kastner* who wanted to deport the families of the laborers, so as not to split the families up (Eichmann agreed saying that happy laborers were better laborers). Kastner also stresses that even as the war ground to a close, the Nazis did what they could to make things bearable for the Jews in Belsen and other western camps. So sincere was Kastner in these beliefs that he actually *went to the Nuremberg Trial* to testify for one of the SS defendants!

On the *other* side, the claims of those who accused Kastner have all been proven false with time. Kastner's accusers claimed that *all* 800,000 Hungarian Jews were killed (these days, it is understood that only the 400,000 Jews in the rural areas were ever even *deported*; the 400,000 Jews in Budapest were left untouched) and that Theresienstadt and Belsen were "extermination camps."

I've unearthed over 100 pages of the most pertinent parts of the Kastner trial transcript, covering all of the above-mentioned points. Also included: a complete chronology of the trial (including the hair-raising finale; the assassination of Kastner by an Israeli intelligence officer), the defense and prosecution's closing arguments, the judge's ruling, and various pieces of submitted evidence.
